## **WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT**

1. In consideration for receiving permission to use facilities owned and operated by **PIEDMONT RECREATION ASSOCIATION** at 509 Homewood Drive SW, Huntsville, Madison County, Alabama ("Property"), I hereby **RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, PIEDMONT RECREATION ASSOCIATION**, or their officers, agents, directors, servants, employees, sponsors, volunteers, affiliates, heirs, and/or successor and assigns (hereinafter referred to as **RELEASEES**) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me, **WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES**, or otherwise, while participating in recreational activities on the Property, or while in, on or upon the Property where such activities is being conducted.
  
2. I am fully aware of the unusual risks involved and hazards connected with this activity, including but not limited to travel risks and/or physical injuries of any type. Further, I am fully aware of the unusual risks and hazard posed to myself, my family and my guests as a result of the ongoing COVID-19 pandemic included with our recreational activities on the Property. I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. **I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that my be sustained by me, or any loss or damage of property owned by me, as a result of being engaged in such activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.**

I further hereby **AGREE TO INDEMNIFY AND HOLD HARMLESS** the **RELEASEES** from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in said activities, **WHETHER CAUSED BY NEGLIGENCE OF RELEASEES** or otherwise. Further, **AGREE TO INDEMNIFY AND HOLD HARMLESS** the **RELEASEES** from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to the participation of any member of my family and/or guests in said activities, **WHETHER CAUSED BY NEGLIGENCE OF RELEASEES** or otherwise.

It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a **RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE** the above-named **RELEASEES**. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Alabama.
  
5. **IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT** I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least nineteen (19) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
